Booth Registration fee:

Eliot Residents - \$35.00 Non-Eliot Vendors - \$60.00
Double fees are charged for 2 spaces, etc.

Arrival Time: Will be assigned - Begins at 6:00 am
NO CAR TRAFFIC BETWEEN 8:00-8:40 AM

Festival hours: 9am - 3pm Breakdown 3pm or later
NO RAIN DATE NO REFUNDS

Booth Details:

- *Booth space is approximately 12"x12" Location assigned by committee
- *Vendors supply their own tables and set ups
- *Only One organization or crafter per booth space
- *Tent spikes are NOT ALLOWED for booths located on the pavement
- *Electricity will NOT be available at the Elementary School or in Hammond Park
- *The use of generators is subject to committee approval at the time of registration
- *No booth breakdowns prior to 3pm
- *Vendor is responsible for clean up of booth and surrounding space
- *The committee reserves the right to reject before or on Sept. 25th ANY item considered unsuitable, inappropriate, objectionable or not family appropriate
- *The committee reserves the right to stop the sale and close the vendor's booth immediately if the vendor ignores the above stated clause
- *The committee reserves the right to reject an application in the event it duplicates a previously accepted vendor's activity

Application Deadlines:

- *Apply by August 1, 2011 to reserve your location space and to be listed in the program
- *Applications will be accepted on a space available basis after August 1st until September 15th. But the vendor's booth or activity will not be listed in the program.
- *A booth assignment map will be mailed to each vendor in early September.
If your application is not accepted your check will be returned within 30 days
